A deposit of \$200 is required for all new residential customers who have never had electric service in their name along with a copy of a valid photo identification card before service will be connected. This deposit will be refunded to you, with interest, if your account remains current at all times during the next 12 months. Commercial and industrial customers will be required to pay a deposit equal to an estimated 2 months usage, at The Village of Tupper Lakes discretion.

In signing this I request the Village of Tupper Lake to provide me with electric service and I agree to keep my account current. All bills are due at the end of the month and full payment is expected unless prior arrangements have been made. If, at any time, these terms are not fulfilled and the account falls in arrears, disconnect procedures could be initiated and the electric service could be terminated and not reinstated until the account is paid in full. At any time during the arrears process a collection agency may be utilized to collect any outstanding debt and this could result in reporting to national credit bureaus of my delinquency. Any individual residing in this home/apt that has an outstanding electric balance from another account, must pay those balances before electric service can be turned on in the applicants name, pursuant to Section 31(1)(a) of the Public Service Law.

The Village of Tupper Lake shall not allow certificates of occupancy or electrical connection to customers who heat with electric heat whether that is by baseboard electric or by electric boiler. There shall be a penalty of \$5.00 for each violation. Each day that the violation continues shall be a new violation. If the violation is not corrected following 10 days' written notice, then the electric service to the violating premises shall be terminated.

In signing this agreement, I agree that I will be assessed a late charge of 1.5% per month on any unpaid balance after the due date.

I also agree that I can be charged a collections charge if my account is sent to a collections agency.

THE VILLAGE OF TUPPER LAKE RESERVES THE RIGHT TO REQUIRE THE LEASEE TO PROVIDE A COPY OF THE LEASE AGREEMENT PRIOR TO APPLICATION APPROVAL.
