**VILLAGE OF TUPPER LAKE ALCOHOL USE POLICY**  
**BOT ADOPTED MAY 20, 2002**

Use of alcohol is permitted by special permit only. Alcoholic beverages other than beer and wine in non-glass containers are prohibited within the Village of Tupper Lake Municipal Park. Kegs and barrels are also prohibited. An approved permit from the Village of Tupper Lake Board of Trustees must be obtained. **No person less than 21 years of age may possess and/or consume alcoholic beverages in any area in the Village of Tupper Lake Municipal Park.**

The Village of Tupper Lake Police Department may check on events when alcohol is being served. The Village of Tupper Lake reserves the right to limit quantities of alcoholic beverages.

If there is alcohol being served, SERVICE OF ALCHOL MUST END one hour before the end of the event (this does not include clean-up time).

If a caterer is used to dispense alcohol, the caterer must have all required permits and/or licenses. In addition, the caterer must submit a certificate of insurance, demonstrating proof that the caterer has the following coverage's:

**Commercial General Liability Liquor Liability**

Limits of \$1 Million each Occurrence, \$2 Million General and Products/Completed Operations Aggregates, \$1 Million Personal/Advertising Injury Liability/\$50,000 Fire Damage Legal Liability and \$5,000 Medical Payment Expense.

**Liquor Liability**

\$1 Million Each Occurrence and \$2 Million Aggregate.

**Worker's Compensation and Employers Liability**

Statutory limits and coverage's.

Village of Tupper Lake shall be listed as an additional insured on the Commercial General Liability and Liquor Policies.
