Call Special Meeting  
To Order Mayor Maroun called the Special Meeting to order at 5:00 pm.

Rescind Tax Cap  
Override Motion by Trustee Shaheen, seconded by Trustee Maroun to rescind the Tax Cap Override from April 19, 2023. (Carried 5-0)

Accept W/S Re-Levy  
To Taxes Motion by Trustee Maroun, seconded by Trustee McClain to accept the Village of Tupper Lake Water & Sewer Re-levy in the amount of \$156,448.27, (Water \$77,751.47, Sewer \$78,696.80). (Carried 5-0)

Revisit Garbage  
Sticker Price Increase Mayor Maroun asked the board to reconsider the proposed \$5.00 per bag garbage sticker price. He has spoken to may residents that this would negatively affect and he asked the board to reconsider.

After a lengthy debate it was so moved by Trustee Maroun, seconded by Trustee McClain to rescind the \$5.00 per bag price to \$3.50 per bag price effective June 1, 2023. (Carried 3-1-1, Trustee LeBlanc “Nay” and Trustee Shaheen “Abstain”)

Celebration Motion by Trustee LeBlanc, seconded by Trustee Shaheen to restrict outside food and drink vendors from the Park Street Celebration planned for May 27, 2023. (Carried 5-0)

Session at 5:30 PM Motion by Trustee LeBlanc, seconded by Trustee Maroun to enter Executive Session at 5:30 pm for the purpose of discussing the medical, financial, credit or employment history of a particular person or corporation, or matters leading to the appointment, employment, promotion, demotion, discipline, discipline, suspension, dismissal, resignation, or removal of a particular person or corporation. Adopt FY2023-24  
Budgets Motion by Trustee Maroun, seconded by Trustee LeBlanc to formally adopt the Village of Tupper Lake FY2023-24 General Fund Budget in the amount of \$3,204,910.34 with estimated revenues expected of \$968,567.00 and appropriated fund balance of \$100,000.00 and total tax levy of \$2,136,343.34 which reflects a tax rate per \$1,000 of \$14.9825. In addition, to also approve the Electric & Water/ Wastewater Department Budgets as proposed.
