Call Special Meeting  
To Order Mayor Maroun called the Special Meeting to order at 5:00 pm.

Adopt FY2022-23  
Budgets Motion by Trustee LaScala, seconded by Trustee Maroun to formally adopt the Village of Tupper Lake FY2022-23 General Fund Budget in the amount of \$3,400,852.20 with estimated revenues expected of \$1,062,138.00 and appropriated fund balance of \$100,000.00 and total tax levy of \$2,238,714.20 which reflects a tax rate per \$1,000 of \$15.7766. In addition, to also approve the Electric & Water/ Wastewater Department Budgets as proposed. (Carried 5-0)

Accept W/S Re-Levy  
To Taxes Motion by Trustee Maroun, seconded by Trustee LaScala to accept the Village of Tupper Lake Water & Sewer Re-levy in the amount of \$119,438.39, (Water \$71,361.01, Sewer \$48,077.38). (Carried 5-0)

Modify April 29, 2022  
Bid Award for Water &  
Sewer Pipes, Valves &  
Fittings Motion by Trustee McClain, seconded by Trustee LaScala to modify the bid awards from April 29, 2022 for Water and Sewer Pipes, Valves, and Fittings as follows, rescind award of Water Bid for Ferguson Waterworks and award it to Blair Supply Corporation for \$18,163.20 for an award savings of \$3,009.20. (Carried 5-0)

Water Quality  
Discussion Trustee LaScala discussed the highlights of our meeting from May 4<sup>th</sup> with NYS DOH, DANC, C2AE and our Water Quality Consultant Claude Cormier from Hydrosorce which focused on our struggles to continue searching for an alternative to our well water and to be able to produce a better quality of water for our community members and to support future developments.
