Motion by Trustee McClain, seconded by Trustee Maroun to approve the 2022 Tax Re-Levy in the amount of \$193,877.76 with 8% Interest of \$15,510.23 for a total amount of \$209,387.99 to be re-levied to the 2023 Town of Tupper Lake and Franklin County Tax Bills. (Carried 4-0)
